



Dear Valued Customers:

The Trucking and Transportation industry has been experiencing an extremely volatile price for diesel fuel. The North American Transportation Council has determined that the cost of diesel fuel represents 17.9% of a trucking company's cost of operations. In order to simplify the fuel surcharges, we will be using the United States Department of Energy's "national U.S. Average Fuel Price" to determine the surcharge.
